## 信息授权书 Information Authorization Letter

1. 本人/本公司同意并授权银行为办理下列业务, 可以依据其自主决定向本人/本公司以及其它组织、机构或个人查证和采集本人/本公司的信息及/或不时地向金融信用信息基础数据库(包括但不限于中国人民银行个人/企业信用信息基础数据库)查询、获取、使用本人/本公司的信用报告及相关信用信息(本人/本公司的信息、信用报告及相关信用资料以下合称“信息”):  
I/We agree and authorize the Bank, may in accordance with its own discretion, from time to time and for any of the following purposes, verify and collect my/our information from any organizations, institutions and individuals and/or access the basic financial credit information database (including but not limited to the PBOC individual or enterprise basic credit information databases) to inquire, obtain, use my/our credit report and credit materials (aforesaid information, credit reports and credit materials are collectively referred to as “Information”):

- (一) 受理审核本人/本公司的信贷、融资和/或委托贷款业务申请; 及受理审核本人/本公司信贷、融资和/或委托贷款业务申请而需要查询其法定代表人、出资人、主要管理者、关联方等信用状况的;  
review the application by me/us for credit facility, financing and/or entrustment loan; and check credit status of Legal Representative, Investor, key manager and related parties which are needed to be reviewed for the purpose of the aforesaid application;
- (二) 受理审核本人/本公司为借款人的信贷、融资申请提供担保的业务申请; 及受理审核本人/本公司提供担保而需要查询其法定代表人、出资人、主要管理者、关联方等信用状况的;  
review the application by me/us for the provision of security for borrower’s credit facility and financing application; and check credit status of Legal Representative, Investor, key manager and related parties which are needed to be reviewed for the purpose of the aforesaid application;
- (三) 对已发放的信贷、融资业务进行贷后风险管理需查询本人/本公司及/或其法定代表人、出资人, 主要管理者、关联方信用状况的; 或  
check credit status of me/us and/or our Legal Representative, Investor, key manager and related parties for the purpose of post-drawdown risk management of drawn facility and financing business; or
- (四) 其他与该信贷融资业务相关需要的。  
such other purposes as required for the credit facility and financing business.

本条项下之授权期限至本人/本公司在上述相关业务项下的全部义务履行完毕且相关业务项下无任何未尽事宜时为止。

The term of authorization under this clause will remain valid until all the above obligations in the relevant business were fully performed without any matters unaccomplished.

2. 在不违反法律、法规或监管部门要求的前提下, 本人/本公司同意并授权银行为以下某个或全部目的向其认为必需或适当的人士(无论在中国境内或境外), 包括但不限于任何星展集团成员、任何向银行提供调查、管理、会计、法律、税务、保险、数据处理、后勤或其它服务的提供者、任何潜在受让人或任何与银行可能会建立信贷文件、融资文件及/或担保文件有关的合同关系的其它人, 以及其它有权监管部门, 披露、转移和/或交换本人/本公司的信息: (1)向本人/本公司提供任何银行服务; (2)将本人/本公司的相关信息资料与银行拥有的本人/本公司的其它信息进行比较; (3)宣传、改善及促进银行和其它星展集团成员向本人/本公司提供的银行服务; (4)存储或处理本人/本公司资料; (5)转让银行在信贷文件、融资文件及或担保文件项下的权利义务; (6)遵守任何国家或地区的任何法律、法规或监管要求; (7)银行合理决定的其它目的。为本授权书之目的, 星展集团指星展集团控股公司(DBS Group Holdings Ltd)及其关联方。

Without violation of laws, regulations and requirements from competent authorities, I/We agree and authorize that, for one or all of the following purposes, the Bank is entitled to disclose, transfer and/or exchange my/our Information to the personnel (whether onshore or offshore personnel) which Bank considers necessary or appropriate, including but not limited to any DBS Group Members, any service suppliers providing investigation, management, accounting, legal, tax, insurance, data processing, logistics or other services for the Bank, and any potential transferee, or any other person who may propose entering into contractual relations with the Bank in relation to facility letter, financing documents and/or security documents, and any competent authorities: (1) providing any banking services for me/us; (2) comparing the Information with other information related to me/us possessed by Bank; (3) publishing, improving or promoting the banking services provided by the Bank and other DBS Group Member(s) for me/us; (4) storing or handling the Information; (5) transferring Bank’s rights and obligations under facility letter, financing documents and security documents; (6) complying with laws, regulations or regulatory requirements of any country or jurisdiction; (7) other purposes reasonably determined by the Bank. For the purpose of this letter, DBS Group means DBS Group Holdings Ltd and its affiliates.

3. 本人/本公司同意并授权银行在其认为必需或适当的期间内保存本人/本公司的信息资料, 不论银行与本人/本公司的关系是否终止。

I/We hereby agree and authorize the Bank to keep the Information for the duration as it shall consider necessary or appropriate, no matter whether the relationship between the Bank and I/We has terminated or not.

4. 本人/本公司进一步同意银行可不时地向金融信用信息基础数据库提供与本人/本公司在银行业务办理过程中所产生的信息(包括但不限于任何逾期还款、信用等级调整、未履行担保义务或其他任何违约事件、终止事件以及由于上述情况所引致的诉讼、仲裁信息等)。

I/We hereby further agree that the Bank may disclose my/our Information (including but not limited to any default in repayment, adjustment of credit rating, default in performing security obligation or other event of default, termination, and any litigation or arbitration resulted from any of the foregoing events) arising from the banking services to the basic financial credit information database from time to time.

5. 本人/本公司在此确认, 本人/本公司可向银行提供本人/本公司相关人员的个人信息(包括但不限于其管理人员、员工、股东和实益所有权人的个人信息) 以与银行建立和维护业务关系。在向银行提供任何个人信息时, 本人/本公司确认该等信息来源于个人信息主体的授权, 本人/本公司依授权合法提供相关个人信息以供银行为以下目的使用和披露: (1) 向本人/本公司提供产品或服务; (2) 满足星展集团的运营、行政或风险管理要求; 及(3)遵守星展集团合理认为必要的、任何法律项下的或任何法院、政府机构或监管机构的任何要求。本人/本公司应确保相关个人信息主体已同意本人/本公司向银行披露该等信息, 允许银行为上述目的使用和披露个人信息, 以及同意接受因该等披露和使用其信息所产生的风险和后果。

with the Bank. When providing any personal information to the Bank, I/we confirm that the provision is made based on the authorization of such person possessing the personal information. I/We lawfully provide such information based on authorization for the Bank to use and disclose for the purposes of: (1) providing products or services to me/us; (2) meeting the operational, administrative and risk management requirements of the DBS Group; and (3) complying with any requirement, as DBS Group reasonably deems necessary, or as required by law or of any court, government authority or regulator. I/we shall make sure that the person or entity possessing the personal information agreed to disclose such information to the Bank who may use and disclose such information for the above purpose, and agreed to undertake the risks and consequence arising from the disclosure and usage of such information.
