

6-Month RMB Structured Investment Product ("SIP") Term Sheet

PRODUCT RISK RATING

The 6-Month RMB Structured Investment Product (the "SIP") is risk rated **P1** and is suitable for investors whose risk profile is **C1 or above**. The investor shall fulfil other requirements that may be set out by the Bank. Please refer to the Financial Needs Analysis and the Customer Rights Instruction for description of the risk profile.

PRODUCT DESCRIPTION

1. **USD/CAD Rate linked structured deposit**
 - This SIP is a USD/CAD Rate linked structured deposit denominated in RMB.
2. **Tenor**
 - The tenor of this SIP is approximately 6 months.
 - During the tenor of the SIP, no early withdrawal or early termination by the Customer is permitted.
3. **Return**
 - The return of this SIP is dependent on the performance of the Spot USD/CAD Rate at the Fixing Time on the Final Fixing Date.
 - If the Spot USD/CAD Rate at the Fixing Time on the Final Fixing Date is equal to or greater than the Higher Strike Rate, the Customer will receive a Return Rate of 2.50% p.a. for the Return Period.
 - If the Spot USD/CAD Rate at the Fixing Time on the Final Fixing Date is lower than the Higher Strike Level, BUT equal to or greater than the Lower Strike Rate, the Customer will receive a Return Rate of 1.70% p.a. for the Return Period.
 - If the Spot USD/CAD Rate at the Fixing Time on the Final Fixing Date is lower than the Lower Strike Rate, the Customer will receive a Return Rate of 0.10% p.a. for the Return Period.

If a SIP order has not yet been confirmed by the Bank as being successfully executed ("Pending Orders"), the Bank will on a best effort basis seek to execute such Pending Orders, but the Bank will otherwise have no obligation with respect to the Pending Orders.
Value Date:	12 March 2025, provided that if such date is not a Payment Business Day, then the Value Date will be the first following day that is a Payment Business Day.
Maturity Date:	Two(2) Payment Business Days after Final Fixing Date, the Maturity Date is scheduled to be 12 September 2025.
Tenor of SIP:	Approximately 6 months.

Permissible Offer Amount:	In integral multiples of RMB 5,000, subject to a minimum of RMB 50,000.
Principal Amount:	The Offer Amount in RMB (or part thereof, as the case may be) transferred by the Bank to the Customer's SIP Account for this SIP on the Value Date.
Settlement Currency:	RMB.
Alternate Currency:	USD.
<u>Redemption</u>	
Redemption on the Maturity Date:	The Bank will pay 100% of the Principal Amount to the Customer on the Maturity Date in the Settlement Currency.

Fixing Time:	3:00pm Tokyo Time (2:00pm Beijing Time)
Beijing Banking Day:	A day on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealings in foreign exchange and foreign currency deposits) in Beijing.
Return Period:	The period beginning on (and including) the Value Date and ending on (but excluding) the Return Payment Date. For avoidance of doubt, for the purpose of determining the Return Period only, the Return Payment Date will not be adjusted according to the Business Day Convention should it fall on a day that is not a Payment Business Day.

Spot USD/RMB Rate:	The official fixing rate that is expressed as the amount of RMB that can be purchased with one (1) USD for settlement in accordance with the convention for such currency pair, reported by the People's Bank of China, Beijing, People's Republic of China, that appears on the Reuters Screen "SAEC" Page opposite the symbol "USDCNY=" at approximately 9:15 a.m. Beijing time, on the relevant date, as determined by the Bank. If no prices are quoted on the relevant Reuters Screen "SAEC" Page (or such other page or replacement page as may be designated by the Bank) or the relevant Reuters Screen "SAEC" Page (or such other page or replacement page) is unavailable for any reason on such date at such time, such spot rate will be determined by the Bank in good faith and in a commercially reasonable manner.

Valuation Method :	The Financial Derivative embedded in this SIP will follow Fair Value Measurement Principle and adopt Market Value Measurement Method, with its valuation being generated from the operation of third party computing system by reference to relevant linked underlying, interest rates, exchange rates and other financial market data as well as valuation model constructed for the relevant products.

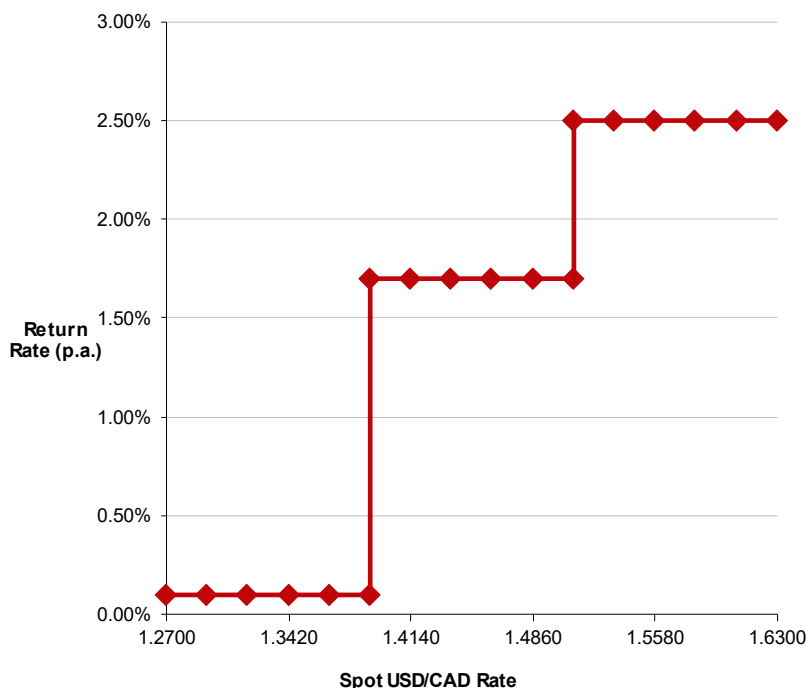

The spot **USD/CAD** Rate may change over time as a result of the interaction of many factors directly or indirectly affecting economic and political conditions in the countries (or special administrative regions) in which such currencies are circulated as legal tender, particularly relative rates of inflation, interest rate levels, the balance of payments and the extent of governmental surpluses or deficits in those countries (or special administrative regions).
- Foreign exchange rates can either be fixed by the government, allowed to float within a range of exchange rates set by the government, or left to float freely. Governments, including those issuing the currencies to which this SIP relates, use a variety of techniques, such as intervention by their central bank or imposition of regulatory controls or taxes, to affect the exchange rates of their respective currencies. They may also issue a new currency to replace an existing currency or alter the exchange rate or relative exchange characteristics by devaluation or revaluation of a currency. Thus, the value of the SIP and amounts payable under the SIP could be affected by the actions of sovereign governments that could change or interfere with previously freely determined currency valuations, fluctuations in response to other market forces and the movement of currencies across borders.
